British Columbia Vision Zero in Road Safety Grant Program Information Package – October 2023

The British Columbia Vision Zero in Road Safety Grant Program (the 'Grant Program') provides up to \$20,000 for each project aimed at protecting vulnerable road users, people who walk, cycle, or scoot, when they travel around their communities. Organizations can use these funds to make infrastructural improvements to roadways, enact policies or enforcement measures, launch educational campaigns, or carry out other innovative projects that make travelling safer and more equitable.

Who Can Apply?

- Local governments,
- Indigenous governments, and
- Non-governmental organizations.*

What Projects Are Eligible For Funding?

- Projects that take place in British Columbia and on roads NOT under Ministry of Transportation and Infrastructure (MoTI) jurisdiction;**
- Focus is on improving the safety of vulnerable road users;
- Aligns with Vision Zero principles of safe roads, safe speeds, and creating safe environments;
- Project activities and expenditures can be completed by March 31, 2025.

*This can include, but is not limited to: school districts, Parent Advisory Councils, road safety advocacy groups, Indigenous Friendship Centres, and charitable organizations.

**Projects involving MoTI right-of-ways are ineligible for funding. These are often, but not always, numbered highways and side roads outside of municipalities. If you have a road safety concern involving these roads, please contact your <u>regional MoTI office</u>.

Program Streams

VISION ZERO BC

Applicants may apply to one of two program streams. Please refer to Our Projects page for examples of funded projects and their program stream.

• Stream #1 is for the design and installation of low-cost infrastructural improvements temporary (pilot) or permanent changes - to roadways. Funds can be used to support costs associated with acquiring engineering department or local government administrator approval for construction-related projects. Implementation of these projects may also involve contributions from partner organizations (e.g., for professional services, labour, materials) to supplement this grant.

This stream can also include other project goals, such as enacting policies or other proven or innovative initiatives that address vulnerable road user safety.

• Stream #2 projects fund projects that are directed by Indigenous communities and governments. This aligns with the BC Government's commitment to reconciliation and working with Indigenous governments in a government-to-government relationship. Indigenous communities can set and direct their own priorities.

Stream #2 grants may include any items listed under Stream #1, but also include other Indigenous-led road safety priorities, such as road safety planning, driver training, impaired driving, community consultations, stakeholder engagement, public awareness, a bikeshare program, etc.

Projects involving MoTI Roads

Projects involving MoTI right of way – most often numbered highways and side roads outside of municipalities – are not eligible to apply for the Grant Program. If you have a road safety concern involving these roads, please contact your <u>regional MoTI office</u>.

To find out whether a road is under MoTI jurisdiction, please go to the <u>iMapBC website</u> and follow the instructions below:

- 1. Click on 'Launch iMapBC' on the right-hand side
- 2. On the left-hand side Home panel, click on 'add layers now'
- Navigate to Transportation > Ministry of Transportation Road Network > select 'Road Features Inventory (RFI) Highways – MoT. The map layer showing MoTI roads has now been selected.
- 4. To view this layer, click 'layers' in lower left corner > the selected layer arrow on the left panel > select 'zoom to visible scale'.
- 5. Roads/Highways with brown lines are under MoTI jurisdiction. Roads that do not have the brown lines are under municipal jurisdiction.

Funding Details

Successful projects can receive up to \$20,000 in funding dependent on its scope and its alignment with the program's principles and goals.

Larger funding amounts are likely to be considered if:

- The project is expected to benefit a large number of people;
- At least one partnership has been secured that offers additional financial contributions; or
- A strong implementation and evaluation plan has been created, and the applicant has sufficient expertise to execute the project successfully.

Funding will not be provided for:

- Profit-making activities, programs, and/or projects;
- Cash prizes;
- Purchases of alcohol and/or other drugs; and
- Ongoing operating expenses for established programs or projects.

Reporting

Grant recipients will be required to complete a midpoint check-in in September 2024, submit a final project evaluation report in April 2025, and applicable photos and communication materials to be uploaded on Vision Zero BC.

Application Process

All applications must be submitted online via the <u>Vision Zero in Road Safety application portal</u> by January 15, 2024 at 3:00PM PST.

Vision Zero Program Timeline

- 1. October 16, 2023: Applications open
- 2. January 15, 2024: Applications close at 3:00PM
- 3. Mid-January February 2024: Adjudication
- 4. Late February March 2024: Notice of decisions
- 5. September 2024: Midpoint check-in/evaluation
- 6. April 2025: Final evaluation report
